

I do not believe that Thomas Jefferson Walker who marries Frances Whittington is the son of the Jeremiah Walker of St. Landry Par, LA. My reasoning is that on the 1850 St. Landry Par, LA Census, Thos Jefferson and wife Frances are living just two doors down from John Whittington and wife Sarah Nelson, Frances' parents. Jeremiah Walker, b. 1808 in TN and his son Thomas can be found on the 1850 Pike Co, MS Census. I think the Jeremiah who is in Pike is the son of the

John Walker who married Sarah Gates and raised a family in Pike and is buried in Pike. These however may be related to the Walkers in St. Landry. There are several Gates families in Dickson Co, TN prior to 1830. It is possible that the Jeremiah who is in St. Landry is related to the John Walker of Pike. Frank Trowbridge has the following opinion:

"Frank Trowbridge (ftrowbridge@juno.com) is of the opinion that John had a brother, Jeremiah, "who was living in Franklin Co, GA, and who "Went West" with the rest of his family. He m. Zebiah (Black?) and they wound up in Yazoo Co, MS." However, there are no Walkers on the 1823 or 1825 Yazoo tax list, and no Walkers on the 1850 Census "

At any rate, I will go ahead and send what I have on Dickson and St. Landry at this time and then look at my research notes some more for more clues that might be of help. You will note that the Walkers in Dickson appear to be the families which June Welch discusses. People have reported however that there are some error's in June's work and so far I have not been able to find a marriage

for Hannah Daniel. This might be moot in the long run.

DICKSON COUNTY, TN

1797 Dickson Co: James Robertson sells to Samuel Walker land on Barton's Creek near a spring near Walker's house [first mention of a house in county.]

3 Oct 1798 (recorded 13 Apr 1799) George Walker of Fayette Co, KY, sells to John Patterson of Knox Co, TN, 100 acs on Middle Fork of Red River in Robertson Co, TN. Wit: James Hust, David Walker, Benj. Mason.

4 Jun 1803 Charles Walker of Robertson Co, TN buys land on Jones' Creek in Dickson Co. John Low and Lakin Walker witnesses.

17 Jun 1803 Charles Walker and Lakin Walker wit land bought on Jones Creek in Dickson Co, bought by John Low of Robertson Co, TN.

12 Dec 1803 Isaac Walker of Montgomery County buys from John Lowe and John Ward, of Robertson County land on west fork of Jones' Creek next to Charles Walker's NE corner, Wit: Charles Walker and Jeremiah Walker registered in Dickson County 24 Feb 1806.

MAR 1804 James Walker elected Register of Dickson County. James gives security of \$2000 with Samuel Walker as security.

Ordered that road be laid off from William Teas on Yellow Creek in Dickson County, to the Montgomery County line on the middle line of Barton's Creek.

- 1813 **Isaac Walker** on jury in Dickson County.
- 1814 Captain Cuthbert Hudson's Company, Dickson Co, TN Militia: The following are the men who served under his company from 28 Sept. 1814 until 28 March 1815:David McAllister corporal, John McCallister corporal, John McAlister private. Note: Many of these men lived in the Turnbull Creek and Beaverdam Creek areas of Dickson County, near the Hickman County line. [War of 1812]
- MAR 1815 Dickson County: " It is ordered by the court that **Isaac Walker**, Milton Dickson, Miner Bibb, George Ross, Jr., Nehemiah Scott and David Hogan who were returned as summoned on the original venire for this term by the sheriff but came not be severally fined in the sum of twenty five dollars unless they appear here at the next term of this court and render sufficient excuse for not attending.
- 1 Mar 1816 Deed from Tennessee to William Nawl, Assignee of Isham Ferguson. In consideration of the military service performed by Isham Ferguson to the state of North Carolina, Warrant No. 4425, dated the 22nd day of December 1796, and entered on the 8th day of March 1809, by No. 3121, as an occupant claim, we have granted to William Nawl, assignee of Isham Ferguson, a tract of land containing one hundred acres, lying on the waters of Jones Creek, beginning on the north side of Four Mile Creek, to include his improvement. Surveyed the 5th day of August 1808. Given under my hand this 28th day of March 1810. Willie Blount, Governor. Grant was registered on the 1st day of March 1816. **James Walker**, Register.

- 23 Mar 1816 Deed from Noah Kelley to John Nall. Indenture made this 7th day of June 1813, between Noah Kelley of Dickson county, and John Nall of the same county, for and in consideration of the sum of two hundred and twenty dollars to him in hand paid by Nall, for a tract of land lying on the waters of Turnbull Creek, and containing one hundred and five acres. Signed: Noah (X) Kelly. Test: Andy Halford, William Nall. Deed was proven in open court at the January term of 1816, and ordered to be registered. Field Farrar, Clerk. Deed was registered on the 23rd day of March 1816. James Walker, Register. [Dickson Co, TN Deed Book B p 540]
- Jul 1816 Montgomery Co, TN: **Charity Walker** places **William Walker**, under 21, as apprentice with Edwin Killebrew.
- July 1816 Montgomery Co, TN: Ordered to work on the road, hands of **Samuel Walker**, **Thomas Walker**, **William Walker**, **Charles Walker**.
- 3 Aug 1816 Deed from Greenbury Roden to Joseph Nail. Indenture made this 3rd day of

August 1816, between Greenbury Roden of Dickson County and Joseph Nail of the same county, for and in consideration of the sum of eighty dollars to him in hand paid by Nail, for a tract of land containing thirty-six acres, beginning at Erl Lewis' north boundary line. Signed: Greenbury Roden. Test: William Nail, Steward Pipkin. [Dickson Co, TN Deed Book C p 138]

- 31 Jan 1817 William Nall, Richard Nall & Edmon Tidwell witnessed a deed from Erl Lewis to Minor Bibb. 31 January 1817. [Dickson Co, TN Deed Book C p 115]

Indenture made this 1st day of May 1812, between William Nall of Dickson county and Benjamin Harris of the same country, for and in consideration of the sum of six hundred dollars to him in hand paid by Harris, for a tract of land lying on the waters of the East fork of Jones Creek, beginning south of Willy Blount's southwest corner, and containing one hundred and sixty acres. Signed: William Nall. Testt: Jesse (X) Stroud, William Austin. Deed was acknowledged in open court at the January term of 1818 and ordered to be registered. Field Farrar, Clerk. Deed was registered on the 4th day of February 1818. Molton Dickson, Register. [Dickson Co, TN Deed Book C p 151]
- 1 Sep 1818 Deed from William Nall to Jehu McClain. Indenture made this 1st day of September 1818, between William Nall of Dickson county, and Jehu McClain of the same county, for and in consideration of the sum of five hundred and fifty dollars to him in hand paid by McClain, for a tract of land lying on the waters of the East fork of Jones Creek, beginning on the north side of Four Mile Creek. Signed: William Nall. Test: David McAdoo, Eldridge Nall. Deed was acknowledged in open court at the October term of 1818 and ordered to be registered. Field Farrar, Clerk. Deed was registered on the 7th day of April 1819. Molton Dickson, Register. [Dickson Co, TN Deed Book C p 209]

15 Sep 1819 William Nall & Minor Bibb were appointed by the court to examine Elizabeth Myers regarding the sale of land by her husband Simon Myers to Jesse Benton. Deed was registered 15th day of September 1819. [Dickson Co, TN Deed Book C p 260] [see 5 Jan 1818]

⁴ Listed as widow of Van Walker when James Robertson conveys 97 ½ acres to Elizabeth Walker 5 April 1805. Do not know who Van Walker is but on 5 Apr 1805, Samuel Walker conveys 5 3/4 acres to Elizabeth Walker, one of the witnesses was Simeon Walker. Simeon Walker and Samuel Walker were brothers of Isaac Walker (1754-1843).

This is evidenced by the Revolutionary War papers of Isaac Walker as well as land transactions in Wilkes Co, NC and in middle Tennessee. Isaac was born in Prince George's Co, MD in 1754 and with his parents and siblings moved to Surry Co, NC and lived in that part of Wilkes which was cut from Surry.
